BELMONT ELEMENTARY PAVING

26 BEST STREET, BELMONT

The Shaker Regional School District is seeking Proposals for the replacement of paving at Belmont Elementary School. Proposals should be separated by the two (2) areas, as outlined on the attached plans, and may be awarded for either, or both. Ideally, the District will replace all of the paving with the exception of the parking spots identified on the attached plans. A mandatory site visit is required and will take place on Friday, April 29, 2019 at 10 am in front of Belmont Elementary School, 26 BEST Street, Belmont N.H. 03220. The following is the scope of this project.

- Saw cut as required
- Remove and dispose existing asphalt or reclaim and use as base
- Excavate existing soil to a depth of 12" and remove any unsuitable materials.
- Supply and install 12" of new gravel (8" bank run gravel & 4" crushed gravel)
- Grade and compact.
- Supply and install machine paved winter binder at 2" compacted.
- Loam and seed areas disturbed by contractor.
- Striping to be done by others.
- Installation of Catch Basin in Area 2
- Work may not begin prior to July 1, 2019 and must be completed no later than August 14, 2019.
- Proposed Contract and Certificate of Insurance must be included with the proposal.
- Proposals are due by noon on May 8, 2019 at the S.A.U. office located at 58 School Street, Belmont, NH 03220.

The District reserves the right to reject any or all proposals and to waive any formalities in proposals received. Price alone may not be the determining factor. The District will determine the extent of the project that most closely meets the needs of the District within budgetary constraints. Prices quoted shall be valid until July 30, 2019.

All sealed proposals are due to the Superintendent of School's Office no later than 12:00 Noon, Eastern Daylight Time, on May 8, 2019. Mailed proposals shall be marked "BES Paving Proposal" on the envelope. A proposal received after the time and date specified will be disqualified.

The Shaker Regional School Board will officially award the contract at its meeting on May 28, 2019 and provide notice to all interested parties, with a purchase order being issued to the awardee.

All proposals must be submitted on the attached proposal and affidavit form. Any deviation from the scope of work, as outlined, must be noted.

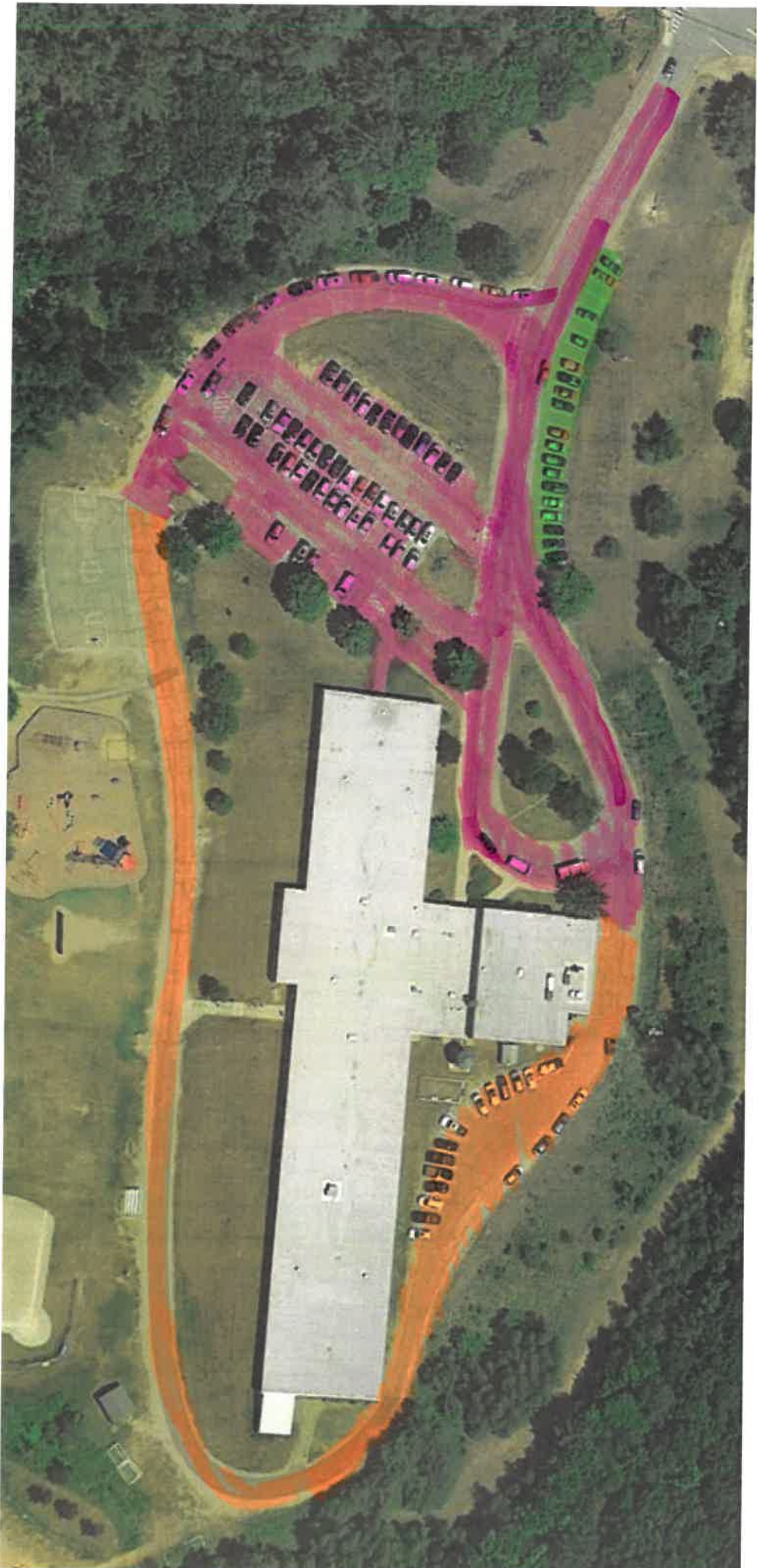
