### **Belmont Middle School Roofing**

The Shaker Regional school District is seeking Proposals for the installation of asphalt shingle tiles to be applied to the pitched roof section (approximately 24 square) on the front center of Belmont Middle School. A site visit is required and will take place on Monday, April 29, 2019 at 1:00 pm in front of Belmont Middle School at 38 school Street Belmont N.H. 03220. The following is the scope of the project.

- Roof measurement to be determined by bidder.
- Remove and dispose of old roofing material to deck.
- Install ice and water shield on all overhangs and valleys.
- Install synthetic underlayment.
- Install white galvanized drip edge along rakes and eaves.
- Install ridge cap as needed.
- Metal valleys to be installed
- New plumbing vent and flashed.
- New metal step flashing where necessary
- Architectural shingles with a minimum warranty of 30 years
- Site to be cleaned everyday of all debris.
- Anticipated work window will be between June 24, 2019 and August 2, 2019; final work window to be determined by the District.
- Contract and certificate of insurance must be included in the proposal.
- Proposals are due by noon on May 8, 2019 at the SAU office located at 58 school Street, Belmont N.H. 03220

The District reserves the right to reject any or all proposals and to waive any formalities in proposals received. Price alone may not be the determining factor. Prices quoted shall be valid until July 30, 2019.

All sealed proposals are due to the Superintendent of School's Office no later than 12:00 Noon, Eastern Daylight Time, on May 8, 2019. Mailed proposals shall be marked "BMS Roofing" on the envelope. A proposals received after the time and date specified will be disqualified.

The Shaker Regional School Board will officially award the contract at its meeting on May 28, 2019 and provide notice to all interested parties, with a purchase order being issued to the awardee.

All proposals must be submitted on the attached proposal and affidavit form. Any deviation from the scope of work, as outlined, must be noted.
